WE IMPORT VEHICLES AS HUMANITARIAN AID FOR THE MILITARY





Vehicles can be imported as humanitarian aid for the Armed Forces of Ukraine in accordance with the Guidelines on the organization of the import of vehicles, military goods, and dual-use items in conditions of martial law.



IMPORTANT!

We draw your attention to the fact that the Declaration on the list of goods recognized as humanitarian aid has been changed.

UNTIL 1 APRIL 2024, YOU CAN CHOOSE TWO OPTIONS FOR DECLARING VEHICLES:



The first option — the generation of a Declaration by the recipient using the Automated Humanitarian Aid Registration System pursuant to the general rules for system use.

WE EMPHASIZE!

Where the vehicle is imported for the Armed Forces of Ukraine, a written confirmation from the military is not required. However, you should bear in mind that the targeted use of such vehicles must be confirmed in the report on the availability and distribution of humanitarian aid to be submitted in accordance with the Procedure as approved by the Resolution of the Cabinet of Ministers of Ukraine No. 953.

Where the recipient of the vehicle is a charitable organization which, after importing the vehicle into the country, transfers it to a unit of the Armed Forces of Ukraine, we recommend that you fill out fields 1–3 of the Declaration on goods recognized as humanitarian aid as follows:

2	USREO Code of the Recipient of Humanitarian Aid*	0000000 (indicate the USREO Code of Charitable Foundation "X")
3	Number of the Recipient in the Unified Register of Recipients of Humanitarian Aid	EP0000 (indicate the number of the Recipient, Charitable Foundation "X", in the Unified Register of Recipients of Humanitarian Aid)

The second option — the use of a paper Declaration.

Where the recipient of the vehicle is a military unit, we recommend that you fill out fields 1–4 of the Declaration on goods recognized as humanitarian aid as follows:

ATTENTION!

Where a Declaration is submitted in paper form, you may NOT indicate the number of the Recipient of Humanitarian Aid, but you should enter the number of a military unit. Also, you may not indicate all other data, if unknown.

With the above in mind, you may proceed filling out the Declaration on the list of goods recognized as humanitarian aid in accordance with the general rules laid down in the Procedure as approved by the Resolution of the Cabinet of Ministers of Ukraine No. 953.
